Ingram was stranded in the Little Maria Mountains northwest of Blythe for 43 hours, but was rescued Tuesday thanks to a dedicated band of men who gave their time and effort to keep him safe.

They were members of the Riverside Mountain Rescue Unit, a non-profit organization whose sole mission is to retrieve lost or stranded people - whether 10,000 feet above sea level or on the hot desert floor.

As Ingram said, "They'll get

### Search and Rescue

3 Oct. - Search for Non-exsistant Victim, #7123 Strawberry Creek drainage - Fern Valley

1815 hours, Sunday night. Once again on our way to Idyllwild. Tonight's action packed adventure is billed as a thirty-two year old man missing about eighteen hours from a cabin in Fern Valley where he has been visiting this week-end. Al Korber and myself are speculating the chances for a Banning abort as Art Bridge drives us towards the mountain. No such luck, the customary Banning sub-station check-in reaffirms currency of the original call with possibilities of another mission also in Idyllwild. 1930, check-in at the Sky Yacht, (Dr. Mellor's cabin) designated rendezvous for this mission. Additional information on victim: name, Wilford Allen Cameron, Al for short, age, 32, 5'11", 180 lbs., blond hair, blue eyes. Wearing blue jeans and a dark plaid shirt. Size 9. Sears type hiking boot. Victim's car parked in Malibu; he rode to Idyllwild with a friend. 1950, Operations Leader Walt Walker sends a field team of Jim Fairchild, Hank Schmel and Al Korber to a dirt road near the cabin where Al was last seen: they will check for tracks. 2010. Walt sends out two more teams consisting of Pete Carlson, Art Bridge and Jack Schnurr, team 1; Dave Hadley, Rich Morris, Bob Nelson and Steve Bryant, team 2. Hank's team was unable to find tracks so the additional teams will join with Hank to sweep down the Strawberry Creek drainage starting about three quarters of a mile above the cabin where the man was last seen.

2200, Los Angeles County Sheriff's deputies check the victim's home in Malibu; no one home. 2215, continuous, intensive searching results in negative results. All teams report to base camp (Sky Yacht) for further instructions. 2245, L. A. deputies check victim's mother's house; find Al asleep in bed.

21 OCTOBER - SEARCH - #7124 Icehouse Canyon - Mt. Baldy area

About 2200 on Thursday evening the worried voice of a husband told of a missing wife, overdue on a short hike into the canyon. The car was there at the roadhead. A daughter at home had refused her mother's invitation to hike along. It was dark and cold, we rolled, not until after another unit had told us they would handle it, only to be prevented by superiors until morning. We organized at the roadhead and started up the trail in a group, ready to split into parties at the saddle. In a little way we came across the husband who had searched fruitlessly. He hiked on back to the cars. We found, followed, and lost tracks, wondering if they were the right ones. No definite tracks at the saddle. Some of us bivouacked there, others at Kelley's Camp, for a whole hour and a quarter. We theorized that if in the wilderness, she must be in the canyon. We made a methodical, intensive search almost all the way back down where we met the West End Sheriff's group. All this time piecemeal information had accumulated to influence us to more than theorize that she might not be in the wilderness. But no, we must not quit. Back up to the saddle, split to search the Cucamonga and Ontario Peaks areas. The West End group searched a couple of peak areas to the north. Toward evening theory became almost fact with another bit of information--she may have left the area with another man. The least of us had hiked twenty miles, all of us found our callout food "old" and in need of replacement, none of us would have given up had there been a reasonable basis for continuing. We adjourned to a local restaurant for dinner, then home for rest. -- Jim Fairchild


